Opening Prayer

I Devotion & Prayer

Deuteronomy 7:11-16

¹¹ Therefore you shall keep the commandment, the statutes, and the judgments which I command you today, to observe them. ¹² "Then it shall come to pass, because you listen to these judgments, and keep and do them, that the Lord your God will keep with you the covenant and the mercy which He swore to your fathers. ¹³ And He will love you and bless you and multiply you; He will also bless the fruit of your womb and the fruit of your land, your grain and your new wine and your oil, the increase of your cattle and the offspring of your flock, in the land of which He swore to your fathers to give you. ¹⁴ You shall be blessed above all peoples; there shall not be a male or female barren among you or among your livestock. ¹⁵ And the Lord will take away from you all sickness, and will afflict you with none of the terrible diseases of Egypt which you have known, but will lay *them* on all those who hate you. ¹⁶ Also you shall destroy all the peoples whom the Lord your God delivers over to you; your eye shall have no pity on them; nor shall you serve their gods, for that *will be* a snare to you.

II Financial Update

Bro Dale presented and reviewed the financials for the month of April.

- General Fund = \$484K, Designated = \$263K, Disaster Relief = \$501, ELC = \$K
 - Reviewed separate statement that listed all of the Disaster Relief monies to date including, Income, Expense Categories, Total Expense and Net Income.
- Disaster Relief As of March 31th:
 - Total Income = \$747,619K
 - Total Expenses = \$270,710K
 - Net Balance = \$476,909K
- Month Expenses = \$218K, Giving = \$216, Variance = (\$2K)
- Current Building Note Balance \$4,093,977
- Reviewed Monthly Bank Statements, P&L, Income Statement, as well as Offering Statement YTD.

 2^{nd} Half Budget Preparation - after this month we will take a look at the numbers and prepare a budget for the 2^{nd} ½ of 2017

III Facilities

- Hall Floors (North and South) a number of the staff worked diligently won the baseboards to complete. Walls in the north and south hallway were painted. Floor mats were installed.
- **Coffee shop** have gotten some feedback on the room. One class asked if they could use. Our plans are to offer a spot that will more to attract the young people to a coffee shop environment. Will be used to meet with the visitors as well. Will meet and talk with them there.
- **Mobile building** –still waiting on DEQ. Michael Looolara reached out to a friend that is an environmental engineer to assist with a permit (review of the forms) for the sanitary wastewater and try to get the application completed.
- Janitorial Service not currently doing well with the janitorial service. One thought (we are paying less than \$50K at this time) was if we hired a part time janitorial supervisor and possibly work with Bro Nathan and the youth. They could potentially work cleaning the church for them to raise money for their camp. Vacuum, mopping floors, etc. We have had several come out look at the job (ICI, Jani King).
- **ELC** Upon Jancie Corie leaving she made a recommendation for bonuses for all of their employees at the ELC. We will request the rationale behind the amounts that were submitted and understand why bonuses we requested.
- **Phone System Voice Mail** Bro Hershel mentioned that we may want to consider revising our voice mail message when our office is closed. We may consider a more

creative message that would allow callers to understand that the office is closed while providing a way to get assistance if needed.

IV Relief Effort (Bro Dale)

• Widows and Seniors. – Bro Dale provided and update. Ms. Euna Bennett – her house is complete. Ms. Martha Eskine – doors delivered (17) interior doors (3) left to paint – cut shoe mold waiting for floor people, then will be done. 5-6 doors to trim and to complete. Should be complete by the end of next week. Bro Hilton Pray – will assist with the cost of the sheet rock and insulation. They will pay for the finishing once hung.
